# **Engineering UTC Northern Lincolnshire Provider Access Policy** 2024-2025

#### Introduction

This policy statement sets out the school's arrangements for managing the access of providers to pupils at the school for the purpose of giving them information about the provider's education or training offer. This policy statement is integrated into our wider careers strategy for Engineering UTC Northern Lincolnshire

This complies with the school's legal obligations under Section 42B of the Education Act 1997.

For pupils of compulsory school age these encounters are mandatory and there will be a minimum of two encounters for pupils during the 'first key phase' (year 8 to 9) and two encounters for pupils during the 'second key phase' (year 10 to 11). For pupils in the 'third key phase' (year 12 to 13), particularly those that have not yet decided on their next steps, there are two more provider encounters available during this period, which are optional for pupils to attend.

These provider encounters will be scheduled during the main school hours and the provider will be given a reasonable amount of time to, as a minimum:

- share information about both the provider and the approved technical education qualification and apprenticeships that the provider offers
- explain what career routes those options could lead to
- provide insights into what it might be like to learn or train with that provider (including the opportunity to meet staff and pupils from the provider)
- · answer questions from pupils.

### Meaningful provider encounters

One encounter is defined as one meeting/session between pupils and one provider.

We are committed to providing meaningful encounters to all pupils using the Making it meaningful checklist.

Meaningful online engagement is also an option, and we are open to providers that are able to provide live online engagement with our pupils.

Our impartial CEIAG careers interviews are delivered by an external provider to ensure we are giving information about all opportunities. All students receive at least 2 one-to-one appointments to look at options in years 11, 12 and 13. Where a student has SEND there are extra appointments offered, supported by the SENCO.

Year 9 and 10 receive group impartial CEIAG meetings with Humber Outreach programme (HOP).

We subscribe to Unifrog and other excellent careers portals to ensure our students receive good careers knowledge through all year groups. This is extra on top of weekly careers lessons and weekly careers tutor activity.

# **Destinations of our pupils**

In 2021-2022 our year 11 pupils moved to range of providers in the local area after leaving the UTC:

- North Lindsey College FE (33%)
- John Leggott College (11%)
- Apprenticeships (HETA, NLC) (16%)
- Grimsby Institute FE (3%)
- Bishop Burton FE (1%)
- Doncaster New College (1%)

In 2021-2022 our year 13 pupils moved to range of providers in the local area after college:

- University (46%)
- Apprenticeship providers (36% of which 27% advanced and 9% higher)
- North Lindsey FE (9%)
- Full time work (9%)

We are proud to be in the top 0.5% of schools and colleges nationally for students going into apprenticeships
